

# PRIVACY AND COOKIES POLICY, IREMITON.COM AND RELATED DOMAINS

This policy, together with our terms and conditions explain how iRemitOn may use information we collect about you, as well as your rights over any personal information we hold about you. Please read this policy and our T&C carefully; by accessing the Website you confirm to have understood and agreed to them.

Information we collect about you

## **We collect information about you when you:**

- visit the Website, and other sites accessible from the Website.
- register with and access our products or services on the Website.
- take part in promotions, competitions, customer surveys and questionnaires.
- contact us eg in writing, call customer services.

We may supplement the information we collect about you with information we receive from other sources eg public registers such as the electoral roll. This allows us to assess the accuracy of the information we hold about you in order to send you relevant offers and information.

## Using your information

### **Collecting your personal information helps iRemitOn to better understand what you need from us. We use your information to:**

- manage and improve the Website.
- personalise our services to you.
- administer and operate your account.
- process your orders and allocate loyalty points to your account.
- tell you about important changes to the Website and our services.
- understand your behaviour to develop and improve our products and services.
- manage promotions, competitions, customer surveys and questionnaires.
- check and verify your identity, and prevent or detect crime. In performing checks

your information may be disclosed to credit reference agencies, who may keep a record of that information. This is not a credit check and your credit rating will be unaffected.

Your personal information is safe with us and will never be released to companies outside iRemitOn.

We may use and share anonymised information for improving our product and services. However, we would like to reassure you that this never includes your personal information.

## **Cookies**

In order to comply with new rules, we use a system of classifying the different types of cookies which we use on the Website, or which may be dropped by third parties through our websites. The classification was developed by the International Chamber of Commerce UK and explains more about which cookies we use, why we use them, and the functionality you will lose if you decide you don't want to have them on your device.

### **What is a cookie?**

Cookies are text files containing small amounts of information which are downloaded to your personal computer, mobile or other device when you visit a website. Cookies are then sent back to the originating website on each subsequent visit, or to another website that recognises that cookie. Cookies are useful because they allow a website to recognise a user's device.

**Persistent cookies** - these cookies remain on a user's device for the period of time specified in the cookie. They are activated each time that the user visits the website that created that particular cookie.

**Session cookies** - these cookies allow website operators to link the actions of a user during a browser session. A browser session starts when a user opens the browser window and finishes when they close the browser window. Session cookies are created temporarily. Once you close the browser, all session cookies are deleted.

Cookies do lots of different jobs, like letting you navigate between pages efficiently, remembering your preferences, and generally improve the user experience. They can also help to ensure that adverts you see online are more relevant to you and your interests.

#### **Strictly necessary cookies**

**These cookies enable services you have specifically asked for. For those types of cookies that are strictly necessary, no consent is required.**

These cookies are essential in order to enable you to move around the Website

and use its features, such as accessing secure areas of the Website. Without these cookies services you have asked for, like shopping baskets or e-billing, cannot be provided.

#### **Performance cookies**

**These cookies collect anonymous information on the pages visited. By using the Website, you agree that we can place these types of cookies on your device.**

#### **Functionality cookies**

#### **Targeting or advertising cookies**
